Midstate Electric Lineworker Scholarship Program

Purpose: Midstate Electric Cooperative (MEC) offers one \$20,000 scholarship for members to attend lineworker school. The recipient must put forward \$5,000 for the remainder of the lineworker tuition. MEC will reimburse the \$5,000 once schooling is completed.

Application: Visit https://www.midstateelectric.coop/scholarship-programs for an application.

Requirements:

Scholastic - Applicant must meet the entrance requirements of the elected school before applying for MEC's scholarship.

Residence - The primary residence of the applicant or parent/guardian of the applicant must be in MEC's service area.

College/Trade School - Any accredited line worker school is acceptable to qualify for MEC's scholarship.

Qualifying Activities - To include, but not be limited to scholastic achievement, future goals, and application presentation.

Application Presentation - Application and attached documentation are neat, typed and grammatically correct.

Award - Scholarship awards will be sent directly to the lineworker school on behalf of the recipient and must be used for tuition, books, and curriculum-related expenses. If the recipient withdraws from the program before the end of the funding period, the school will refund the remaining unused portion of the scholarship to MEC. Additionally, if the recipient does not complete the program, all tools and supplies provided must be returned to MEC.

Applicant Photo – Please attach a professional headshot or school photo (taken from the shoulders up).

Duration - MEC's line worker scholarship must be used within 12 months of being awarded.
