## MEC Pays Capital Credits to Members

Your Midstate Electric Cooperative board of directors has reviewed the financial condition of the cooperative and is pleased to announce the retirement of \$1,300,000 in capital credits. In mid-December, members who purchased power during 2007 and a portion of 2008 will receive capital credit refunds in proportion to how much they contributed to that year's margins. Because electric cooperatives operate at cost, any excess revenues (margins) are allocated and retired to members in the form of capital credits. Margins are retained by the cooperative and used for several years as opposed to borrowing money, thus lowering the cost of providing electricity.

Members look forward to receiving a little

extra cash around the holidays each year. This cash, provided by capital credit refunds, is just one of the advantages of doing business the cooperative way.

## Stay Safe During a Winter Power Outage

**Whether there is planned power outage or mother nature strikes, you should be prepared with an easily accessible emergency kit.**

Supplies should include:

- **A flashlight, headlamps, battery or solar-powered lantern, radio, and fresh batteries.** Keep the batteries separate until you are ready to use them.
- **Candles and matches.** Do not leave lit candles unattended.
- **Bottled drinking water.** Store at least 1 gallon per person per day. If a storm is in the forecast, fill the bathtub with water so bathroom facilities can still be used by pouring a bucket of water down the toilet to create a vacuum flush.
- **Kindling and dry firewood** if you have a fireplace or wood stove.
- **Clothing.** In cooler weather, wear extra

layers and a hat. Have sleeping bags and blankets handy, too.

- **Easy-to-prepare food items.** Buy items that do not require much cooking. Canned or instant soups, stews, chili, packaged freeze-dried meals, and protein or breakfast bars are good to have on hand.
- **Gas camp stoves, lanterns, or barbecues.** Make sure to have extra fuel for cooking outdoors. Never use a camp stove or barbecue indoors. Be sure to use any lanterns on a flat, stable, and nonflammable surface.
- **An ample supply of essential prescription medications and over-the-counter drugs.** During a storm, road travel may not be possible for several days.
- **A first-aid kit.** Make sure all supplies are filled and ready to go. If you have a medical condition, have a backup plan to enact at a moment's notice.

# Holiday Lighting Safety Tips

As you decorate your homes and businesses for the holiday season, please keep safety on your mind.

The following tips can help keep your family bright, happy and safe:

- ▶ Use holiday lights that are approved by a nationally recognized testing organization, such as Underwriters Laboratories (UL).
- ▶ Before hanging your lights, inspect them for frayed wires, broken sockets or other signs of wear and tear.
- ▶ Avoid connecting more than three strings of lights together, unless the directions indicate otherwise.
- ▶ When using extension cords, avoid routing them under rugs or near walkways.
- ▶ If you decorate a real tree, water it every day and prevent the lights from coming into contact with tree branches.
- ▶ If you choose an artificial tree, make sure it's certified as fire resistant.

Look for the UL label.

- ▶ For outdoor decorating, only use lights and power strips that have been approved for outdoor use.
- ▶ Keep electrical connections off the ground and make sure wiring is clear of downspouts, railings and aluminum siding.
- ▶ Fasten holiday lights securely to buildings, trees and other outdoor surfaces to prevent damage from wind or jostling.
- ▶ Be careful when using metal staples or nails as fasteners. They can damage the protective insulation covering the wires.
- ▶ Turn off lights late at night or whenever you are away from home. Consider using a timer.

While safety is your first concern, don't forget about energy efficiency. LED lights use up to 80% less energy than traditional lights and they have a longer lifespan. LEDs are also cool to the touch, reducing the risk of fire. Look for LEDs that are ENERGY STAR® certified.
