**Equal Access for All**

When Midstate Electric Cooperative was founded, each member contributed an equal share to gain access to electricity. Each member had an equal vote in co-op matters.

That sense of equity and inclusion is still how we operate today. Membership is open to everyone in our service territory, regardless of race, religion, age, disability, gender identity, language, political perspective or socioeconomic status.

By paying your electric bill each month, you are a member of the co-op, and every member has an equal voice and vote when it comes to co-op governance. This ties back to our guiding principles of equitable economic participation and democratic control of the co-op.

We encourage all members to vote in MEC's director elections. This year, board of director elections for districts 1, 2, 8 and 9 will be at MEC's 2021 Annual Membership Meeting on Saturday,

May 8. Candidates may be nominated for director by filing a petition signed by at least 15 members of the cooperative who reside in that district. Petitions must be filed on or before Tuesday, March 9, and may be obtained at MEC's headquarters facility.
